Fusion 360

Target Audience

The Autodesk Certified User (ACU) Fusion 360 exam is designed for an individual who has a foundational level of proficiency and hands-on experience with Fusion 360 (approximately 150 hours), has proven competency at an industry entry-level, and is ready to enter into the job market.

Candidate Description

A successful candidate for this certification is familiar with Fusion 360 features and capabilities, as well as relevant workflows, processes, and project objectives. They are competent using the core tools in the Fusion 360 Design, Render, and Drawing workspaces. They can perform basic Fusion 360 tasks related to component and assembly modeling with limited assistance from peers, product documentation, and support services. They have the ability to answer routine conceptual and applied questions about how to use Fusion 360 without referring basic questions to others. Additionally, they are able to comprehend a technical drawing and have a basic concept of drafting standards.

Prerequisites

It is expected that all candidates will have a general understanding of:

- Demonstrate proficiency with basic computer skills and digital literacy
- Apply correct industry standard terminology
- Understand the concepts associated with general technical drawing and design
- Access online and written reference materials including the help screens within Fusion 360

Objective Domain

Some of the topics and features of the software that may be covered in the exam are listed below each objective.

Note: Within the context of this exam series, all references to “create, select, manage, etc.” indicate “know how to create, select, manage, etc.”

1. Workspace and Navigation

1.1 Get started

- 1.1.a Navigate the Data panel
 - i. File structure of project level folders,
 - ii. Cloud organization
 - iii. Access versions
 - iv. Share projects
- 1.1.b Orient a model view
 - i. Orbit, Zoom, Pan, and Look At
 - ii. ViewCube
 - iii. Set Current View options

1.2 Navigate the workspace and environment

 - i. *Edit Form tool (manipulating points, faces, and edges)*

4.1 Create and manage assemblies and subassemblies

- 4.1.a Activate a component or subassembly to edit
 - i. *Bodies and sketches*
- 4.1.b Update a component to the most recent version
 - i. *Use the Get Latest tool*

4.2 Create a component from a body

4.3 Align and/or position components with joints

- 4.3.a Apply joints to components
 - i. *Rigid, Revolute, and Slider*
 - ii. *Understanding degrees of freedom and grounding*
- 4.3.b Manipulate components
 - i. *Move and rotate components after they have been placed into the assembly workspace*
- 4.3.c Drive joints
 - i. *Define the angle or distance of movement of joints*
